ANNOUNCEMENT UNAUDITED CONTRACTED SALES DATA FOR APRIL 2019

This announcement is made by Central China Real Estate Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company hereby announces that, in the month of April 2019, the Group achieved property contracted sales of RMB5,921 million, representing a year-on-year increase of 51.4%, with a contracted sales gross floor area (“**GFA**”) of 866,114 square metres (“**sq.m.**”), representing a year-on-year increase of 49.1%. The average selling price per sq.m. for April 2019 amounted to RMB6,836, representing a year-on-year increase of 1.5%.
