## **ANNOUNCEMENT UNAUDITED CONTRACTED SALES DATA FOR MAY 2020**

This announcement is made by Central China Real Estate Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company hereby announces that, in May 2020, the Group achieved property contracted sales of RMB8,404 million, representing a year-on-year increase of 18.1%, with a contracted sales gross floor area (“**GFA**”) of 1,113,234 square metres (“**sq.m.**”), representing a year-on-year increase of 3.8%. The average selling price per sq.m. for May 2020 amounted to RMB7,549, representing a year-on-year increase of 13.8%.

The average selling price per sq.m. for the five months ended 31 May 2020 amounted to RMB7,252, representing a year-on-year increase of 10.3%.
