## **ANNOUNCEMENT UNAUDITED CONTRACTED SALES DATA FOR JULY 2022**

This announcement is made by Central China Real Estate Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company hereby announces that, in July 2022, the Group achieved property contracted sales of RMB2,119 million, representing a year-on-year decrease of 8.8%, with a contracted sales gross floor area (“**GFA**”) of 324,592 square metres (“**sq.m.**”), representing a year-on-year increase of 5.4%, and with the average selling price per sq.m. amounted to RMB6,528, representing a year-on-year decrease of 13.5%.

For the seven months ended 30 July 2022, the Group achieved total property contracted sales of RMB16,158 million, representing a year-on-year decrease of 51.6%, with a total contracted sales GFA of 2,239,484 sq.m., representing a year-on-year decrease of 48.6%, and with the average selling price per sq.m. amounted to RMB7,215, representing a year-on-year decrease of 5.8%.
